Best of Breed Competition Non-Regular Classes Involving Single Dog Entries

Dual Champion Dog/Bitch Classes: This class is open only to those dogs that have received a Ch title and an AKC Ch title in any other AKC event. Dogs with a JC title only are not eligible. *Entrants must be intact. They may not be spayed or neutered.*

Bred by Exhibitor (BBE) Class Eligibility

- All dogs entered in the Bred by Exhibitor Class must be individually registered with the AKC.
- The person handling the dog must be a breeder of record of the dog and an owner of record of the dog.
- To exhibit in this class, family members must be a breeder and owner of record.

BEST BRED-BY-EXHIBITOR COMPETITION

RULES: During the course of regular judging, the assigned judge will select a Best Bred By Exhibitor from the Bred-By-Exhibitor class winners. This will be done after the Best of Breed/ Variety Competition unless the Best Bred-By-Exhibitor award is automatic. Example: An entry from the Bred-By-Exhibitor class is awarded Best of Winners or Best of Breed. Only dogs and bitches undefeated in a Bred-By-Exhibitor class are eligible for the Best Bred-By-Exhibitor Competition. If the first place winner is not present, the second place winner may not compete. NO ADDITIONAL FEE IS REQUIRED.

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)

Note: As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won the class. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Stud Dog Class: For Stud Dogs and two of their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the stud dog need not necessarily be owner of the get. While the merits of the stud dog are not to be considered in the placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a regular class, Best of Breed Competition, or some other Non-Regular class. The Stud Dog shall be considered one entry and requires one entry fee.

Brood Bitch Class: Same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get

Brace Class: Two dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. At least one dog must be entered in another class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be designated "Brace No. 1," Brace No. 2," etc. Fee for this class is \$25.00 as a Unit.

SPECIAL NOTE: As adopted on September 11, 2012, by the AKC Delegate Body – per AKC rules applying to dog shows, Chapter 16, Section 1: "At the National Specialty, the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a 3 point major, provided that the number of dogs competing in the regular classes of the Reserve Winners' sex totals at least twice the number required for a 5 point major, in the region in which the event is held. No major for Reserve Winners shall be given based on an award of Best of Winners. In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included."

According to the 2016 point schedule for Division 8 (Washington State's division), the floor of a five-point major in dogs is 24; therefore, a minimum number of 48 eligible class dogs must be in competition for RWD to be awarded a 3 point major. The floor of a five point major in bitches is 26; therefore, a mininum number of 52 eligible class bitches must be in competition for RWB to be awarded a 3 point major.

JUNIOR SHOWMANSHIP

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form. NOTE: Juniors with a dog also entered in another class offered at this show who substitute a dog not entered in this show must remit the difference between Junior only and Junior as an additional class entry fee. Juniors who have entered Junior Showmanship only, who then substitute another dog, will not be charged a further fee.

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned or exhibited by professional handlers meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's



book, steward's book & the catalog. Dogs must be handled by an owner/handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the point show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner-Handled Series competition. If the replacement handler is an eligible owner/handler for that dog a change can occur. Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

SWEEPSTAKES

The Sweepstakes is open to all Basenjis who are 6 months and under 18 months of age on the day of the show. Entrants in Puppy Sweepstakes need not be entered in another class at this Specialty. Indicate "Sweepstakes" and age division on the regular entry form under "Additional Classes."
