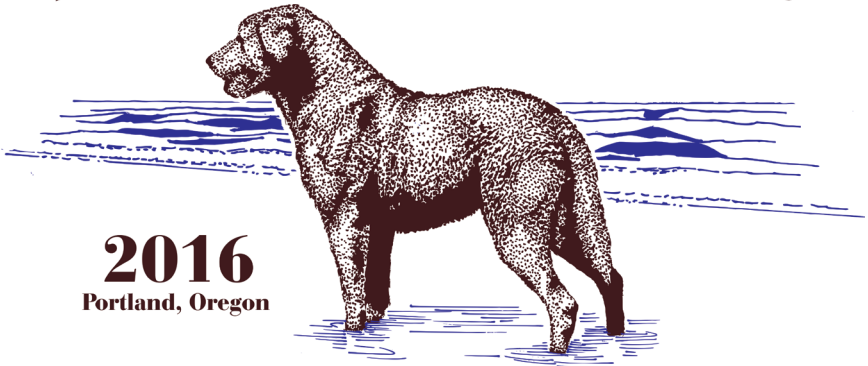

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned or exhibited by professional handlers meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled by an owner/handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the point show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner-Handled Series competition. If the replacement handler is an eligible owner/handler for that dog a change can occur. Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

*****Important***** Please do not book reservations on any other website. Please use only the Holiday Inn website or book directly with the hotel. The ACC has a block of rooms reserved which we would like to fill. Thank you very much.

Cancellation of guestroom reservations are required a minimum of 24 hours in advance of arrival date. Any reservations cancelled within less than 24 hours notice will be charged a One Night Room and Tax cancellation penalty.

CUT OFF DATE for room discounts/block: It is required that all reservations be received on or before 9/13/2016, 12:00 midnight. Reservation requests following the cut off date will be reserved on a space and rate available basis.

CHECK IN / CHECK OUT: Check in time is 3:00 p.m. and check out time at 12:00 noon. The hotel will make all reasonable efforts to accommodate requests for early check in and late check out, however, cannot guarantee these requests. Guests that do not check out by the designated time, without approval by the Resort, will be charged an additional night stay.

DOG SHOW POLICIES

- The hotel will charge a one time, non-refundable pet fee of \$35.00 per room with pets, per stay. Additionally, if there are damages to the room or hotel, charges will be assessed and billed to individual guest.
- The hotel will designate an area outside the Conference Center kitchen for dog washing stations. The hotel can provide heated water for the cost of \$100.00 per week. The group is responsible for providing washing tubs, towels, clean up, and plastic for the grooming area/path to grooming area from washing station. The group has the option to provide its own heated water source at no charge.
- The hotel will transport guests and their dogs to and from the airport. Dog crates can be broken down and dogs will be permitted to ride with their owners as long as they are on a lead. It is helpful to the hotel to have arrival/departure times of guests to ensure appropriate staffing and reduce shuttle wait times.
- Dogs are prohibited in the restaurant, lounge, on 7th & 8th floor, and banquet/meeting rooms, where food is, or will be served, with the exception of grooming and show areas.
- Maximum of (4) dogs are allowed in each guest room. Any additional dogs in each guestroom must be pre-approved by the hotel. All dogs must have their own crates. Plastic is required to be placed under all crates. No exceptions.
- Dogs must be crated when unattended in guest rooms. Under no circumstances will dog washing be permitted in hotel guest rooms. The hotel staff will report an infraction of this rule immediately to hotel management. Guests must allow guestrooms to be served each day.
- Owners/Exhibitors must clean up after their dogs inside and outside the hotel. Please restrict dogs to designated outside exercise and walking areas. Appropriate waste disposal bags must be used for clean-up. Group is responsible to provide these bags.
- Upon arrival at Hotel, the guests with dogs in their rooms will sign a copy of the Hotel's Pet Rules, which will be submitted to the hotel staff and placed on file.

ON SITE RV PARKING

RV parking is on a paved parking lot adjacent to the hotel with a grassy exercise area for dogs. RV parking by advance reservation only. The Show Committee will provide the Holiday Inn with a list of reservations a minimum of 15 days in advance. Space is limited to fifteen (15) self-contained units. Deadline for Reservations / Cancellations is September 21, 2016.

Reservation Fee is \$45.00 per night for RV parking for guests without hotel reservations. If a Guest occupies a guestroom and there are available RV spaces on September 21, 2016 parking will be allowed for those RVs at the rate of \$25.00 per night.

Payment must be received at the time the reservation is made. Payment can be made by check, money order, or PayPal. If you wish to park next to someone please mail your reservations together. An acknowledgement will be emailed back to you when we receive your reservation.

No hookups are available. External generators are permitted. Quiet hours will be 10:00 p.m. to 7:00 a.m. No discharge of gray water or sanitary tanks on the ground or in open containers is permitted. Please contact the RV Coordinator for information on sanitary tank pumping services. If sawdust or shavings are used, they must be cleaned up before you leave. Use of this parking privilege is at your own risk. Neither the American Chesapeake Club, the Show Committee, the Holiday Inn or RV Coordinator assumes any responsibility or liability for damage or loss to any vehicles, their contents, or dogs.

Motor homes and RV's may be parked only in the designated RV parking area. Fire lanes must be kept open at all times. Vehicles parked illegally or in an area other than the designated RV area, will be subject to towing at owner's expense with no prior notice. Exhibitors are responsible for cleanup of their own RV spaces. RV parking is a privilege extended by the Holiday Inn and the Specialty Committee. Exhibitors are asked to be considerate of their neighbors. The RV Chair has the authority to allocate space and to ask that any problems be remedied. The RV Coordinator will provide a Parking Pass when you arrive/ check-in which must be displayed in a visible location on your motor home or RV.

EXHIBITORS PLEASE NOTE! THE FOLLOWING PERTAINS TO ALL EVENTS!

RINGSIDE: Dogs may arrive at any time prior to their scheduled time of judging. Judges will not wait for any dog. Owners and agents alone are responsible for the presence of their dogs at ringside when their class is called. The club, judges, stewards and secretary have no obligation or responsibility to announce for or locate dogs that are not at ringside when required.

LIABILITY: It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. The club, hotel, and any of their agents or employees will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children.

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment. All persons attending this show hereby waive any claim for damages against the host clubs in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.

Points for Reserve Available: At the National Specialty, the Reserve Winners Dog and Reserve Winners Bitch will each be awarded a three-point major, provided that the number of dogs competing in the regular classes in each sex is at least twice the number required for a five-point major in the region in which the event is held.

Awards of Merit: At the judge's discretion, an Award of Merit may be awarded to any dog or bitch present in the Best of Breed ring except BOB, BOS, Select Dog/Bitch, & Winners Dog/Bitch. The maximum number of Awards of Merit awarded will be 10% of the number entered in Best of Breed, with a minimum of two.

Entrants in Veterans need not be intact. Spayed and neutered animal are eligible.

Entrants in Field and Hunting classes must be intact. They may not be spayed or neutered.

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)

Note: As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won the class. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Stud Dog Class: For Stud Dogs and two of their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the stud dog need not necessarily be owner of the get. While the merits of the stud dog are not to be considered in the placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a regular class, Best of Breed Competition, or some other Non-Regular class. The Stud Dog shall be considered one entry and requires one entry fee.

Brood Bitch Class: Same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class: Two dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. At least one dog must be entered in another class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be designated "Brace No. 1," "Brace No. 2," etc.

PUPPY SWEEPSTAKES

Puppy Sweepstakes is open to all Chesapeake Bay Retrievers who are 6 months but less than 18 months old on the day of the sweepstakes. Dogs must also be entered in one of the regular classes.

VETERAN SWEEPSTAKES

Veteran Sweepstakes is open to all Chesapeake Bay Retrievers who are at least 8 years of age on the day of the Sweepstakes. Entrants must also be entered in a regular or non-regular class. Entrants may be altered.

Distribution of Prize Money – Sweepstakes & Veteran Sweepstakes

Thirty-five (35%) percent of sweepstakes entry fees will be retained by the club for expenses.

The remaining 65% (for each Sweepstakes: Puppy & Veteran) will be awarded as follows:

Best in Sweepstakes 15% of total Sweepstakes net entry fees

Best of Opposite Sex in Sweepstakes 10% of total Sweepstakes net entry fees

Placements receive a percentage of the net entry fees of the class entered:

First Place - 30% • Second Place - 20% • Third Place - 15% • Fourth Place - 10%.

All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to Club.

SWEEPSTAKES RULES – PUPPY & VETERAN SWEEPSTAKES

Professional handlers must be an owner, co-owner or breeder of the entry.

Indicate the Sweepstakes Class, with age division, in the space provided for Additional Classes on the entry form. Champions of record are eligible to compete.

JUNIOR SHOWMANSHIP

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.**NOTE: Juniors with a dog also entered in another class offered at this show who substitute a dog not entered in this show must remit the difference between Junior only and Junior as an additional class entry fee. Juniors who have entered Junior Showmanship only, who then substitute another dog, will not be charged a further fee.**

AKC SANCTIONED 4-6 MONTHS PUPPY

- One combined class will be offered for dogs that are (4) four months & under (6) six months on the day of the show.
- An AKC registration number or AKC litter number will be required.
- Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.
- AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise.
- Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4 & Under 6 Months Puppy in Show Competition.

For the 6th consecutive year, we will celebrate the versatility of our breed with the Triple Crown Versatility Challenge. The 2016 NSS Committee would like to honor those handler/dog teams that successfully compete in multiple disciplines by offering a challenge meant to inspire more of us to get out there and accomplish great things with our dogs! (Please note: For the purposes of this Challenge, Obedience & Rally = 1 discipline and Conformation & Sweepstakes = 1 discipline.)

Tracking: Qualifying score in tracking.

Agility: Qualifying score in any agility class offered.

Obedience/Rally: Qualifying score in any regular or optional titling obedience and/or rally class offered or placement in non-regular class.

Conformation/Sweepstakes: Best of Breed, Best of Opposite Sex, Select Dog/Bitch, a Judge's Award of Merit or by making the cut in the Best of Breed competition, Placement in any regular or non-regular conformation class. (Please note: in Stud Dog and Brood Bitch classes, placements are awarded only to the parent dog, not to any of the representative offspring.) Placement in any Puppy or Veteran Sweepstakes class also qualifies.

Field: Qualifying score in any Working Dog Stake (WD, WDX, WDAQ).

Example 1: "Fido" is entered in Rally Advanced B, Rally Excellent B, Open Dog in conformation, and the WD for field. Fido qualified in Rally Advanced B and placed third in Rally Excellent B. In Open Dog, he did not get a placement. Since his first two "goals" were both in Rally, and he failed to get a placement in Conformation, he does not meet the Triple Crown Challenge until the field, when he passes the WD.

Example 2: "Ripple" is entered in Veteran Obedience, 8+ Year-Old Bitch in Veteran Sweeps, Veteran Bitch 8-10 Years in Conformation, and the WD for field. She places in Veteran obedience, is second in her Sweeps class, and goes first in her Veteran conformation class. She's already met the Triple Crown Versatility Challenge before she hits the field!
