- NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.
- OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.
- MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Section 2 - Entry and Eligibility - Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- · A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must
 be handled by a non-professional handler. Professional handlers are defined as any person who
 belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise
 advertised or represented themselves as handling dogs for pay within the last five years. Dogs may
 not be exhibited by current assistants and household members of a professional handler.

AKC NATIONAL OWNER-HANDLED SERIES

The purpose of the AKC National Owner-Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner-Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.

- Dog must be marked as eligible to compete in the AKC NOHS prior to the closing of entries. There is no additional fee to enter this competition.
- Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner-Handled Series competition (Group and Best in Show). Any person may exhibit the dog in the regular Group and Best in Show competitions.
- Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form. The handler must be an owner of record according to the AKC's records as of the date of the show. Dogs declared eligible will be identified by an asterisk or other representative mark in the judge's book, steward's book, and the show catalog.
- *Professional handlers, household members and current assistants to professional handlers may not exhibit.
- The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.
- *Professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Eligibility restrictions apply to all members of the same household. Household members and current assistants to professional handlers in conformation are not eligible to exhibit in this competition. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend. Eligibility restrictions apply to all members of the same household.

USE OF RAMPS – ALL BREEDS


A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, American Water Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Cirneco dell'Etnas, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs, and Norrbottenspets (Misc.).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. (03/2017)
