Non-Regular Classes Involving Single Dog Entries

Veteran Dogs 1 Veteran Bitches 1 A class for Dogs and a class for Bitches 6 yrs. and under 10 yrs. Veteran Dogs 2 Veteran Bitches 2 A class for Dogs and a class for Bitches 10 years and over Entrants in Veterans Classes need not be intact. Winners of the above non-regular classes, if otherwise undefeated, are eligible to compete in Best of Breed competition. BEST OF BREED (VARIETY) COMPETITION SELECT DOG SELECT BITCH

There will be competition for Best Puppy from the Regular Puppy Classes

BEST OF BREED COMPETITION – The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

Non-Regular Classes Involving Multiple Class Entries

Note: Non-regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.

Stud Dog Class and Brood Bitch Class: Each entry is allowed two get. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get must be entered in a regular class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get being exhibited, must wear armbands. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Brace Class: Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

FAX ENTRIES: Fax number: 360-755-2248. \$4.00 per dog per show added for FAX-Credit Card entries. Both sides of entry form must be transmitted. Entries must be accompanied by a cover sheet stating the number of pages, what shows and how many dogs per show. Visa, MasterCard, and American Express are accepted for Fax entries. Credit card information (Credit Card number, expiration date, and cardholder name) must be on cover sheet. Note: Visa and MasterCard users – You must include the 3-digit security code that appears above your signature on the back of the card. Proof of fax transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Ch. 11, Sec. 4). CANCELLATIONS, CHANGES AND TRANSFERS will be accepted according to AKC Rules. Any refunds will be made within three weeks after the show. An administration fee may apply.

AWARDS OF MERIT – ALL SHOWS

At the conclusion of Best of Breed, the judge may at their own discretion, award up to 1 in every 10 entries of specials, an Award of Merit. The judge is not obligated to award any Awards of Merit, if there are not any dogs or bitches in competition worthy of this award. All dogs competing in the Best of Breed competition are eligible for this award with exception of the Best of Breed winner.

PUPPY SWEEPSTAKES

REQUIREMENTS & CLASSIFICATION

Puppy Sweepstakes is open to all Boxers that are at least 6 months of age & under 18 months of age on the day of the show. Dogs shown in Puppy Sweepstakes must also be entered in one of the regular classes at the regular entry fee and on the regular entry form. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class." No Boxers may be entered that have completed their championship at the time entries close. The following classes will be provided for both dogs and bitches.

Puppy, 6 Months & Under 9 Months Puppy, 9 Months & Under 12 Months Junior, 12 Months & Under 18 Months

DIVISION OF ENTRY MONEY AS PRIZES

30% of total entry fees will be retained by the Club for expenses. The remaining 70% will be divided as follows:

VETERAN SWEEPSTAKES

The Veteran Sweepstakes is open to all Boxers, who, on the day of the show, will be at least six years of age or older. Entry fee is \$25. Write VETERAN SWEEPSTAKES in the "Additional Class" space and state the AGE DIVISION.

REQUIREMENTS & CLASSIFICATION

Sweepstakes is open to all Boxers that are at least 6 years of age on the day of the show. Dogs shown in Veteran Sweepstakes need not be entered in regular classes. Indicate your Veteran Sweepstakes Class with the age division in the space provided for "Additional Class." Veteran Boxers who are Champions may be entered. Dogs and Bitches which have been altered (castrated or spayed) may be entered. The following classes will be provided for both dogs and bitches:

Females in season are not permitted to compete in Obedience or Rally

If a female is withdrawn from competition because it came into season and the event superintendent is notified no later than one half hour prior to the start of the first class in the trial, the club is required to refund the entry fee. Oregon Boxer Club will retain a \$15.00 administrative fee per event for each bitch withdrawn. Obedience and Rally are separate events. If bitch is entered in more than one class in the same event on the same day, \$15.00 will be the total amount withheld. If bitch is entered in one event both days, total fee will be \$30. If bitch is entered in two events both days, total fee will be \$60.00.

JUNIOR SHOWMANSHIP COMPETITION

- **NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.
- **OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.
- MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.
- **NOVICE AND OPEN CLASS DIVIDED:** Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.
- NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.
- NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in any competition during the entire show.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.

No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years

**A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend.


