- NOTICE TO EXHIBITORS -



The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

These events will be open from 7:00AM until 10:00PM each day. Consult Judging Program for time of judging.

- The AKC will collect a \$1.50 AKC Event Service Fee and a 50 cent Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Chapter 11, Section 2). At every licensed or member club rally trial, a recording fee of \$3.00 shall be required for each entry of each dog. (Rally Regulations, Ch. 1, Sec. 3).
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTER-NATIONAL MONEY ORDERS IN U.S. FUNDS
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned
 entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry
 Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or
 the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH ENTRANT.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge
 or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered
 incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES or
 OVERPAYMENTS. The Superintendent will make every effort to find all duplicate interes, but if entry has been
 processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the
 management it is impossible to open, or to complete the Show NO REFUND will be made.
- ENTRIES WILL BE ACKNOWLEDGED after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify the Superintendent at (360) 683-1507 or email dogshows@dbamlg.com
- FAX ENTRIES Fax entries will be accepted up to closing time. Fee is \$4.00 per dog per event. If the credit card
 charge is denied for any reason, an additional service charge of \$20.00 will be added. FAX NUMBER: (360) 6836654. This is for Fax Machine ONLY. Incomplete or illegible Fax entries are not acceptable as a valid entry in a
 show. Proof of transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Ch.
 11, Sec. 4). A Fax-Friendly entry blank PDF is available for download at www.BarayEvents.com
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Superintendent will add a \$20.00 collection
 fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may
 result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- The judging will start promptly. Dogs may arrive anytime prior to their time of judging, and may leave immediately
 thereafter, unless required for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to turnish any service for notifying exhibitors or their agents of Breed or
 Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for
 the presence of their dogs in the judging rings.
- NO DOGS WRONGLY ENTERED IN A CLASS may be transferred to another class, except as provided in Ch. 11, Sec. 6 of the AKC rules.
- Only dogs eligible for this show will be admitted into the show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children on the day of the show.
- TROPHIES & PRIZES will be awarded in the ring to the person exhibiting the dog. No awards will be mailed.
- ALL RIGHTS TO TELEVISE, VIDEOTAPE, ADVERTISE, PHOTOGRAPH, PROMOTE or otherwise exploit this event are
 vested in the Club, or in persons to whom assignments of such rights have been made in writing by the Club. All

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed Competition: dogs that are Champions of Record and dogs according to their owners' records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owners' records.

SEXUALLY ALTERED CLASS DOGS SEXUALLY ALTERED CLASS BITCHES

A class for Neutered Dogs and a class for Spayed Bitches. Class will be judged following Best of Breed competition. Winners of these classes are not eligible for Best of Breed Competition.

Non-Regular Classes (Involving multiple dog entries)

STUD DOG CLASS: For Stud Dogs and two of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed competition, or some other non-regular class.

BROOD BITCH CLASS: For Brood Bitches and two of their Produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. The owner of the Brood Bitch need not necessarily be owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered in a regular class, Best of Breed competition, or some other non-regular class.

ENTRY FEE of \$25.00 will be charged for each UNIT (Stud Dog and two get or Brood Bitch and two produce) in addition to the entry fee for the regular classes.

NOTE: As the judge's decision in the Stud Dog and Brood Bitch Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by veterinarian, judge, or tester or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, or other acts beyond the control of the club, it is impossible to open or compete in the trial, test, no refund of entry fees will be made.

Dogs must be ready for their classes. Test/Trial judges have the authority to refuse to judge any dog which does not appear within five minutes of being called for its run. The Trial Club and the Trial Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not bought into the arena when required.

The Trial Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Club or any official thereof.

Exhibitors must be governed by any rules or regulations of civil authority, building and parking restrictions. Vehicles parked contrary to regulations will be subject to towing at the owner's expense.

- The American Kennel Club will issue a Herding Started (Herding Intermediate) [Herding Excellent] certificate for an eligible dog, and will identify the titlist by the use of the letters HS (HI) [HX] after the name of the dog in all official AKC records, once the dog has been certified by three different judges to have received qualifying scores in Started (Intermediate) [Advanced] classes at three licensed or member herding trials.
- Until specified otherwise in the Herding Regulations, the requirements that a dog must earn a title in order to enter the next highest class are waived. An owner may enter a dog in any trial class he or she deems appropriate. However, once a dog has acquired a qualifying score in an upper class at a licensed or member trial, it shall be ineligible for entry in any lower class.

JUNIOR HANDLING

Junior Handling is now available in performance events. As explained to us, the junior handler must handle his/her own dog or the dog of a family member. Junior handler competes in the regular classes and if he/she qualifies a special form is completed and signed by the judge and sent to AKC. If the junior handler qualifies the dog to its title, he/she will receive recognition from AKC.

According to the 2nd Edition of The Clean Run Book of Agility Games by Bud Houston, here is the briefing for Boxed Pairs:

"The Boxed Pairs course is divided into two separate sequences. One dog will be designated to run the first sequence and the other dog the second sequence. Handlers are required to carry and exchange a baton. The first handler can choose to lead out or start with the dog. The second handler is not allowed to lead out. While performing the exchange, both dogs and handlers must be in the exchange box. Failure to do so results in a disqualification for passing out of the zone.

Both handlers should become familiar with both parts of the course.

If the first dog faults an obstacle, that team must return to the exchange box, exchange the baton, and the second tem continues the course beginning with the obstacle at which the first dog made the error. The second dog continues on until he has run the first half of the course. Should the second dog fault any obstacle, that team must return to the exchange box and again exchange the baton. The alternate team must then resume the course from the point of the fault.

When the first half of the course has been successfully run, a scheduled exchange of the baton takes place. The relay continues as in a standard relay with the second side of the course, except that faults force baton exchanges in the exchange box.

Every time an obstacle is faulted, the judge will signal the handlers to change places.

The active dog (the dog that is supposed to be running at any time) will be faulted for taking an obstacle out of sequence. If the exchange dog performs an obstacle on the way to the obstacle faulted by the other team, that dog, too, is called for a fault and must immediately return to the exchange area to hand off the baton to the other team. The inactive dog may perform any obstacle going back to the box."
