

While the merits of the stud dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the Standard for the breed. Get must be entered in a Regular Class, Best of Breed Competition or some other non-Regular Class.

**Brood Bitch Class:** Same rules as for Stud Dog, except substitute Brood Bitch for Stud Dog and Produce for Get.

**Brace Class:** Two Labrador Retrievers that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The Dogs comprising a Brace MUST be named at the time of entry. In making entries for "Brace Class Only" full particulars MUST be given for each dog on individual entry forms. An entry form for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be designated "Brace No. 1," Brace No. 2," etc. The entry fee for Brace Competition is \$19 per dog as a first or additional entry.


