AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Professional handlers,* household members and current assistants to professional handlers** may not exhibit. Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition. Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

***A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.*

EXHIBITORS PLEASE NOTE! THE FOLLOWING PERTAINS TO ALL EVENTS!

RINGSIDE: Dogs may arrive at any time prior to their scheduled time of judging. Judges will not wait for any dog. Owners and agents alone are responsible for the presence of their dogs at ringside when their class is called. The club, judges, stewards and secretary have no obligation or responsibility to announce for or locate dogs that are not at ringside when required.

LIABILITY: It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. The club, hotel, and any of their agents or employees will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children.

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety.

Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment.

All persons attending this show hereby waive any claim for damages against the host clubs in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.

JUNIOR SHOWMANSHIP

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form. **NOTE: Juniors with a dog also entered in another class offered at this show who substitute a dog not entered in this show must remit the difference between Junior only and Junior as an additional class entry fee. Juniors who have entered Junior Showmanship only, who then substitute another dog, will not be charged a further fee.**

Points for Reserve Available: At the National Specialty, the Reserve Winners Dog and Reserve Winners Bitch will each be awarded a three-point major, provided that the number of dogs competing in the regular classes in each sex is at least twice the number required for a five-point major in the region in which the event is held.

Awards of Merit: At the judge's discretion, an Award of Merit may be awarded to any dog or bitch present in the Best of Breed ring except BOB, BOS, Select Dog/Bitch, & Winners Dog/Bitch. The maximum number of Awards of Merit awarded will be 10% of the number entered in Best of Breed, with a minimum of two.

Non-Regular Classes Involving Single Dog Entries

Entrants in Veterans need not be intact. Spayed and neutered animal are eligible.

Field Trial Dogs Field Trial Bitches

Entrants must have received a JAM or better at an AKC license or member Field Trial

Hunting Dogs Hunting Bitches

Entrants must have a JH, SH, or MH title.

Entrants in Field and Hunting classes must be intact. They may not be spayed or neutered.

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)

Note: Non-regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.

Stud Dog Class and Brood Bitch Class: Each entry is allowed two get unless otherwise specified. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get must be entered in a regular class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get being exhibited, must wear armbands. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Brace Class: Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

PUPPY SWEEPSTAKES

Puppy Sweepstakes is open to all Chesapeake Bay Retrievers who are 6 months but less than 18 months old on the day of the sweepstakes. Dogs must also be entered in one of the regular classes.

Best in Sweepstakes 15% of total Sweepstakes net entry fees
Best of Opposite Sex in Sweepstakes 10% of total Sweepstakes net entry fees

Placements receive a percentage of the net entry fees of the class entered:

First Place - 30% • Second Place - 20% • Third Place - 15% • Fourth Place - 10%.

All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to Club.

Recipients of the Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch, and Award of Merit will receive a Crufts eligibility Qualifying Award Certificate to enter the Crufts Dog Show, March 5-8, 2020, at the National Exhibition Centre (NEC) in Birmingham, England, United Kingdom. Details can be found at www.the-kennel-club.org.uk which notes the testing procedures should be started at least seven (7) months prior to the Crufts Dog Show.

2019 Triple Crown Challenge

For the 9th consecutive year, we will celebrate the versatility of our breed with the Triple Crown Versatility Challenge. The 2019 NSS Committee would like to honor those handler/dog teams that successfully compete in multiple disciplines by offering a challenge meant to inspire more of us to get out there and accomplish great things with our dogs! We challenge you to start training now in order to meet our challenge to qualify and/or place in a minimum of three different classes across at least two different NSS disciplines.

To meet the Triple Crown Challenge, a dog might place and/or qualify in Novice B, Team Obedience and the WDX. Another dog might qualify in the WD, a sweepstakes class, and in a Bred-By Exhibitor Class. Dogs who meet the Triple Crown Challenge will receive a special award and the dog's Triple Crown accomplishments will be published on the 2019 NSS Website and in The ACC Bulletin.

All prizes will be presented at the banquet or at the WD/X/Q ribbon ceremony (depending on when the dog meets the challenge). Prizes will be presented to each dog's owner of record, if present; otherwise the awards will go to the handler. **Entering is easy and it's only \$20 to play, but dogs must be pre-registered by August 14 (when entries close).**

To pre-register, send an email to Mel Phillips (melphillips@yahoo.com) by August 14th with the name of the Owner/Handler, the registered name of the dog and then you will receive payment information which is then, immediately due for \$20.

Dogs that meet the challenge must submit a completed Triple Crown Record Form to Mel Phillips at the show AFTER competing (either before the banquet or before the WD ribbon ceremony). Please print a copy of the record form on the next page or from the ACC NSS website. Any questions? Please contact: Mel Phillips.

Qualifications for the Triple Crown Challenge

(Qualify and/or place in any three classes, across a minimum of two NSS disciplines.)

Agility: Qualifying score in any agility class offered.

Obedience/Rally: Qualifying score in any regular or optional titling obedience and/or rally class offered or placement in non-regular class.

Conformation/Sweepstakes: Best of Breed, Best of Opposite Sex, Select Dog/Bitch, a Judge's Award of Merit or by making the cut in the Best of Breed competition, Placement in any regular or non-regular conformation class. (Please note: in Stud Dog and Brood Bitch classes, placements are awarded only to the parent dog, not to any of the representative offspring.) Placement in any Puppy or Veteran Sweepstakes class also qualifies.

Field: Qualifying score in any Working Dog Stake (WD, WDX, WDQ).

Example 1: "Fido" is entered in Rally Advanced B, Rally Excellent B, Open Dog in conformation, and the WD for field. Fido qualified in Rally Advanced B and placed third in Rally Excellent B. In Open Dog, he did not get a placement. Since his first two "goals" were both in Rally, and he failed to get a placement in Conformation, he does not meet the Triple Crown Challenge until the field, when he passes the WD.

Example 2: "Ripple" is entered in Veteran Obedience, 8+ Year-Old Bitch in Veteran Sweeps, Veteran Bitch 8-10 Years in Conformation, and the WD for field. She places in Veteran obedience, is second in her Sweeps class, and goes first in her Veteran conformation class. She's already met the Triple Crown Versatility Challenge before she hits the field!

Rules for the WD/X/Q: Copies of all the Rules and Guidelines, procedures are available for download on the ACC website at <http://www.amchessieclub.org> The entry form will also be on the WD/X/Q page on the 2019 National Show Specialty site. Also download guidelines for Judges & Handlers and Suggested Line Procedures. Read through these rules before the day of the test. The judges will go over the basic rules with everyone quickly before the start of the stake and you can ask a few questions then if needed. This will help you and your dog to be successful and not fail due to handler error. One important rule to remember is you cannot send your dog until you hear the Judge call your number.

Requirements: (see complete info on the printouts listed on the ACC website)

WD: back to back singles on land and water

WDX: a double on land and a double on water, dogs must be steady and deliver to hand

WDQ: a double on land, a land blind, a water blind and a combination triple with two birds in water and one on land. Dogs must be steady and deliver to hand

Directions: Driving time from Host Hotel (Best Western Auburn) is 41 minutes, about 23 miles.

What to Bring: Water for you and your dogs, shade equipment, bug spray, lawn chair, whistle, flat buckle collar and leash, boots, and your lunch. Pickup all trash and take it with you.

Lunch: Participants are responsible for their own lunch.

Volunteers needed: Marshals for each stake, person to bag birds for the judges, live-bird gunners, people to pop/throw the dead bird for each stake, equipment luggers, grounds person to oversee parking and post/remove the signs, someone to pickup lunches for the judges, and a test dog for each stake that isn't running. When dogs are running, please do not walk around in the gallery, avoid loud talking and do not wear white. Any of these can be very distracting to the dogs and the contestants.

At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks.
