

- NOTICE TO EXHIBITORS -

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The AKC will collect a \$1.50 AKC Event Service Fee and 50 cent Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Ch.11, Sec. 2). In accordance with AKC Rally regulations, the AKC will collect a \$3.00 per entry of dog Rally Event Service Fee. A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for AKC.
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNA-TIONAL MONEY ORDERS IN U.S. FUNDS.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
