EXCLUSIVE VIDEO POLICY & RELEASE

The professional video services and live streaming at this show are governed by an exclusive video contract with the Club. No other commercial video recording, video recording from a tripod, monopod or other supported camera/device, or any video recording or streaming of large parts or whole classes shall be permitted. The contract terms permit individuals to record small bits of video of their own dogs only, and using handheld devices only (e.g. phone, tablet or small camcorder). Individuals may post recorded videos of their own dogs to social media (Facebook, YouTube, etc). However, during show hours LIVE Broadcast Streaming to social media (e.g., Facebook Live) is not permitted.

Submission of an entry form and/or physical presence on the show grounds shall constitute both implied and real consent for both the handler and the dog to be professionally video recorded and streamed live only by the professional video services as contracted by the Club for this show. All rights to video record and live stream or otherwise exploit this event and/or the persons or animals participating in it, including the names, likenesses and biographical matter of dogs, owners, handlers, breeders and kennels participating in the event shall belong solely to the show giving Club and/or the American Kennel Club, Inc. No spectator, participant, owner, handler, breeder or kennel shall make commercial use of any video recordings of any person or animal participating in this event without prior written approval from the Club. This event may not be broadcast to social media (e.g. Facebook Live, etc) without prior written approval from the Club.

WINNERS DOG WINNERS BITCH
BEST OF BREED (VARIETY) COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Select Dog and Select Bitch, where applicable, will be chosen immediately following Best of Breed competition. This will be followed by Best Owner-Handled and Best From the Bred-By-Exhibitor Classes.

Reserve Winners Dog and Reserve Winners Bitch will be awarded a three-point major, provided the criteria set forth in Chapter 16, Section 1 of the Rules Applying to Dog Shows is met.

NON REGULAR CLASSES INVOLVING SINGLE ENTRIES

Winners of the Single Entry, Non Regular Classes if otherwise undefeated, compete for Best of Breed; therefore, all entrants MUST also meet ALL American Kennel Club requirements for Non-Regular Classes involving single dog entries.

The following classes are divided by sex.

VETERAN 7 YRS & OVER DOGS VETERAN 7 YRS & OVER BITCHES
Veteran 7 yrs & over: Class for dogs and class for bitches 7 years old and over.
Veteran class entrants at an independent specialty may be altered.

WORKING DOGS WORKING BITCHES

Working Dog/Bitch: Class for dogs and class for bitches holding an AKC Companion or Performance Title. Working class entrants MUST be intact.

BEST BRED BY EXHIBITOR COMPETITION

Best Bred by Exhibitor will be awarded from the First Place winners in the Regular Bred by Exhibitor Classes ONLY immediately following Best of Breed judging. If the Best of Breed is awarded to a dog/bitch coming from one of the Bred by Exhibitor Classes for that breed, the Best Bred by Exhibitor win is automatic.

OBEDIENCE TRIAL CLASSES

Qualifying score required for all prizes in Titling Classes.

A Dark Green Qualifying Ribbon will be given to each dog attaining a Qualifying Score.

Regular Classes: Novice A & B, Open A & B, Utility A & B

Optional Titling Classes: Beginner Novice A & B, Graduate Novice, Graduate Open

Preferred Classes: Preferred Novice, Preferred Open, Preferred Utility

RALLY TRIAL CLASSES

Rally Ring will be 40' X 50'

Qualifying score required for all prizes.

A Dark Green Qualifying Ribbon will be given to each dog attaining a Qualifying Score.

Regular Classes: Novice A & B, Intermediate, Advanced A & B, Excellent A & B, Master

OBEDIENCE & RALLY EXHIBITORS: TRANSFERS WILL BE ACCEPTED FOR THESE TRIALS ACCORDING TO AKC REGULATIONS.

JUMP HEIGHT MUST BE INDICATED ON ALL APPLICABLE OBEDIENCE & RALLY CLASSES

PLEASE NOTE: Refund of entry fees for bitches entered in Obedience/Rally that come in season after closing date of this show may be obtained provided that a veterinarian's certificate and a request in writing is received by the Event Secretary no later than 30 minutes prior to the start of judging.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

THE AKC NATIONAL OWNER HANDLED SERIES

This is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not solely owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog.

Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. *Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog within the last five years.*

Entries into the Amateur-Owner-Handler class are automatically entered into the AKC NOHS and do not have to check the box on the entry form.

AKC SANCTIONED 4-6 MONTHS PUPPY

Entries Close Wednesday 12:00PM PST, March 4, 2020 at the Superintendent's Office.

One combined class will be offered for puppies that are (4) four months & under (6) six months. There will be a selection of Best 4 & Under 6 Months puppy in Breed, and Best Opposite Sex in Breed.

A foreign born dog may enter this class if they are registered in the country of origin.

Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend.

AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise. Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4 & Under 6 Months Puppy Competition.

At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks.
