The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owners' records. If at the end of the 90 day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

SPECIAL NOTICE - CLUSTER OBEDIENCE TRIAL & RALLY TRIAL

With the approval of the American Kennel Club, Obedience Trial classes and Rally Trial classes at the cluster will be consolidated to provide maximum efficiency in scheduling and judging. The Judging Program will include a complete list of breeds to be judged, and the order in which they will be judged. All Specialties in this Cluster that are offering Obedience Classes and/or Rally Classes will be judged together. Each dog will be judged and individual scores recorded in the respective breed's judge's book. For the group exercises in Obedience, all breeds will be judged in one group. If there are more dogs competing than can be spaced four (4) feet per dog on one side of a ring, some must be judged in another group. The judge will divide the class into equal sections and the group exercise will be judged after each section. Following completion of group exercises, the judge will complete the judge's books for all dogs entered in each Obedience class in the respective breed's judge's book. Ribbons and awards will then be awarded by breed. Qualifying points in Obdience are based on the number of dogs in each breed only.
