Produce must be entered in a regular class. Best of Breed competition, or some other non-regular class. NOTE: As the judge's decision in the Stud Dog and Brood Bitch Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.
