Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. The owner of the Brood Bitch need not necessarily be owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered in a regular class, Best of Breed competition, or some other non-regular class. *NOTE: As the judge's decision in the Stud Dog and Brood Bitch Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.*
