The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

**STUD DOG**. For Stud Dogs and two of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the Stud Dog need not necessarily be owner of the get. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for the breed. Produce must be entered in a regular class, Best of Breed competition or some other non-regular class.
