

(Whippets may be examined on the ground, on a table or on a ramp). Basset Hounds are expected to be judged on the ramp during breed judging. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)
