

#### JUNIOR SHOWMANSHIP COMPETITION - EACH DAY

**NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

**NOVICE AND OPEN CLASS DIVIDED: Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 816-3776. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

#### **USE OF RAMPS**

At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: Clumber Spaniels, Sussex Spaniels, Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. (Whippets may be examined on the ground, on a table or on a ramp). Basset Hounds are expected to be judged on the ramp during breed judging. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

#### IMPORTANT NOTICE TO ALL EXHIBITORS

#### Aisles of 15 feet around each ring must be kept clear. NO UNENTERED DOGS PERMITTED AT RINGSIDE.

Each exhibitor is responsible for cleaning up after his own dog(s). Pooper-scoopers will be placed around the show grounds for your convenience. If your dog soils in the show ring, the ring steward will hold your dog while YOU do the cleanup. PARENTS SHALL BE RESPONSIBLE FOR THEIR CHILDEN AT ALL TIMES! NO SKATEBOARDS, ROLLER BLADES OR BIKES WILL BE ALLOWED ON THE SHOW GROUNDS. Grooming and exercise pens in DESIGNATED AREAS ONLY. Crates may be brought to ringside during breed judging and must be removed immediately when juding for that breed is over. PLEASE NOTE: NO GROOMING OR SMOKING UNDER SHADE TENTS IN AISLES. ALL CRATES MUST BE REMOVED FROM RINGSIDE 60 MINUTES AFTER SHOWING. Dogs must leave ringside immediately. You must provide a safe shelter for your dogs after Judging is completed.


