

NOTICE TO EXHIBITORS

American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The AKC will collect a \$3.00 AKC Event Service Fee on each entry of a dog, and 50 cent Recording Fee for the first
 entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered
 in more than one class in the show, the Recording Fee to be collected on the first entry only. (AKC Rule. Ch.11,
 Sec. 2). In accordance with AKC Rally regulations, the AKC will collect a \$3.00 per entry of dog Rally Event Service
 Fee. A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for
 AKC.
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTER-NATIONAL MONEY ORDERS IN U.S. FUNDS
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries
 cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms
 without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent
 assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's
 agent. RESPONSIBILITY FOR THE COMPLETENESS OF ENTRY RESTS SOLELY WITH THE ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Superintendent will add a \$20.00 collection
 fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may
 result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- FAX ENTRIES Fax entries will be accepted up to closing time. Fee is \$4.00 per dog per show. If the credit card
 charge is denied for any reason, an additional service charge of \$20.00 will be added. FAX NUMBER: (360) 6836654. This is for Fax Machine ONLY. Incomplete or illegible Fax entries are not acceptable as a valid entry in a
 show. Proof of transmission is not proof of receipt of a legible or complete transmission (under AKC Rule Ch. 11,

- ENTRIES WILL BE ACKNOWLEDGED after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify the Superintendent at (360) 683-1507 or email dogshows@barayevents.com.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. The Superintendent will make every effort to find all duplicate entries, but if entry has been management it is impossible to open, or to complete the Show NO REFUND will be made. - Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any
 service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding
 up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- · Only dogs eligible for these events will be admitted into show area. There is no provision for unentered dogs.

Best Bred By Exhibitor will be awarded from the First Place winners in the Bred By Exhibitor Classes ONLY immediately following each breed. If the Best of Breed is awarded to a dog/bitch coming from the Bred By Exhibitor Class for that breed, the Best Bred By Exhibitor win is automatic. Best Bred by Exhibitor Group will be judged following the Variety Group that included that breed. First through Fourth Place in each Group will be awarded, with the Group Winner going on to Best Bred By Exhibitor in Show. If the dog/bitch judged First in their respective regular group was also the Best Bred by Exhibitor for their breed, first place in the BBE Group is automatic, and judging will be for second through fourth places only. Judges for Best Bred by Exhibitor in Breed and Best in Show will be as published for the regular classes. Bred by Exhibitor Group judges will be announced the day of the show.

BEST OF BREED (VARIETY) COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

SELECT DOG SELECT BITCH

GRAND CHAMPION COMPETITION – The following categories of dogs are entered in this competition: 1. Dogs that are Champions of Record competing in Best of Breed or Best of Variety class. 2. Dogs transferred to Best of Breed/Variety which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. 3. Champions that win Non-Regular Classes and become eligible for Best of Breed competition. (Altered or spayed CH veteran class winners at independent specialties are eligible.) 4. Winners Dog and Winners Bitch are not eligible for Grand Champion competition. At the judge's discretion, Grand Championship points may be awarded to: 1. Best of Breed or Variety 2. Best of Opposite 3. Select Dog 4. Select Bitch. Grand Champion competition will not continue beyond Best of Breed competition and in breeds that are divided into varieties, Grand Champion Competition will not continue beyond Best of Variety competition.

ADDITIONAL RULES

- · All Dogs shall be kept on leash except when in the Obedience or Rally ring.
- Grooming areas will be designated and grooming rules will be posted and strictly enforced. There will
 be no set-ups, generators, exercise pens or grooming within 30 feet of any rings. Crates will be allowed
 at ringside immediately prior to your breed judging, but must be removed immediately following.
- Exhibitors and handlers will be held responsible for clean conditions in and around grooming and/or parking areas.
- The Hurricane Ridge Kennel Club of Washington, Inc. will provide shade tents on the north and south sides of the Conformation Rings. These may be used by Exhibitors waiting to go into the ring. No chairs or grooming allowed.
- Exhibitors are asked to clean up after their own dogs, PLEASE. Designated exercise areas are clearly marked.
- Exhibitors will be required to furnish their own cover and electricity.
- No parking is allowed on the streets around the show site. Violators will be towed. Entrance to the show grounds is from Blake Avenue ONLY.
- Food will be available on the show grounds.

USE OF RAMPS

At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: Clumber Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Basset Hounds, Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. Whippets may be examined on the ground, on a table or on a ramp. Basset Hounds are expected to be judged on the ramp during breed judging. For the judging of Juniors, the ramp may be used at the discretion of the judge for the ramp breeds. This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)



- ABSOLUTELY NO BATHING OF DOGS is allowed in ANY of the guest rooms, guest room bathrooms or bathtubs.
- Dogs MUST be on a leash in public areas of the hotel at all times.
- Dogs MUST be exercised in the designated dog area.
- You MUST pick up after your dog! DO NOT allow your dog to urinate on buildings, garbage containers, sign kiosks, etc. Use grass, trees and shrubs only.
- NO DOGS are to be left UNATTENDED in guest rooms at ANY TIME!
- No dogs are allowed IN or ON beds.
- Dogs that are excessively barking must be removed from the premises in respect for the other guests in the hotel.
- Do NOT take dogs into non-dog-allotted rooms. This creates problems for persons with allergies and requires special post-dog cleaning.
