

VETERAN DOGS VETERAN BITCHES

A class for Dogs and a class for Bitches Six years and older. Dogs/Bitches entered in Veterans Class need not be intact. Spayed and Neutered animals are eligible. Winners of the Veterans classes, if otherwise undefeated at this show, are eligible to compete for Best of Breed

#### BEST OF BREED (VARIETY) COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

#### **GRAND CHAMPION COMPETITION**

The following categories of dogs are entered in this competition: 1. Dogs that are Champions of Record competing in Best of Breed or Best of Variety class. 2. Dogs transferred to Best of Breed/Variety which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. 3. Champions that win Non-Regular Classes and become eligible for Best of Breed competition. (Altered or spayed CH veteran class winners at independent specialties are eligible.) 4. Winners Dog and Winners Bitch are not eligible for Grand Champion competition. At the judge's discretion, Grand Championship points may be awarded to: 1. Best of Breed or Variety 2. Best of Opposite 3. Select Dog 4. Select Bitch. Grand Champion competition will not continue beyond Best of Breed competition and in breeds that are divided into varieties, Grand Champion Competition will not continue beyond Best of Variety competition.

#### Non-Regular Classes (Involving multiple dog entries)

**STUD DOG CLASS:** For Stud Dogs and at least two, but not more than four of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed, or some other non-regular class.

**BROOD BITCH CLASS:** Same rules as for Stud Dog. Substitute Brood Bitch for Stud Dog, and Produce for Get.

BRACE CLASS: Two Bulldogs that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The dogs comprising a Brace MUST be named at the time of entry. Entry fee for Brace Class as a UNIT (2 dogs) is \$20.00. In making entries for "Brace Class Only" full particulars MUST be given for each dog on individual entry forms. An entry form for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as part of a Brace MUST be

marked accordingly in the space provided for Additional Classes. "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be so designated – "Brace No. 1," Brace No. 2," etc.

NOTE: As the judge's decision in the Stud Dog, Brood Bitch or Brace Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

**NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.
