BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed Competition: dogs that are Champions of Record and dogs according to their owners' records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owners' records.

ALTERED CLASS DOGS ALTERED CLASS BITCHES

A class for Neutered Dogs and a class for Spaved Bitches, Class will be judged following Best of Breed competition. Winners of these classes are not eligible for Best of Breed Competition.

Non-Regular Classes (Involving multiple dog entries)

STUD DOG CLASS: For Stud Dogs and two of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed competition, or some other non-regular class.

BROOD BITCH CLASS: For Brood Bitches and two of their Produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. The owner of the Brood Bitch need not necessarily be owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered in a regular class, Best of Breed competition, or some other nonregular class.

ENTRY FEE of \$25.00 will be charged for each UNIT (Stud Dog and two get or Brood Bitch and two produce) in addition to the entry fee for the regular classes.

NOTE: As the judge's decision in the Stud Dog and Brood Bitch Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

BRACE CLASS: Two dogs of identical ownership. The Dogs comprising a Brace MUST be named at the time of entry. If both dogs are entered in another class at the show, entry fee for Brace Class as a UNIT is \$25.00. If either or both dogs are not entered in another class at this show, entry fee is \$25 for each unentered dog, plus \$25 for Brace as a UNIT (2 dogs). In making entries for "Brace Class Only" full particulars MUST be given for each dog on individual entry forms. An entry form for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class."
