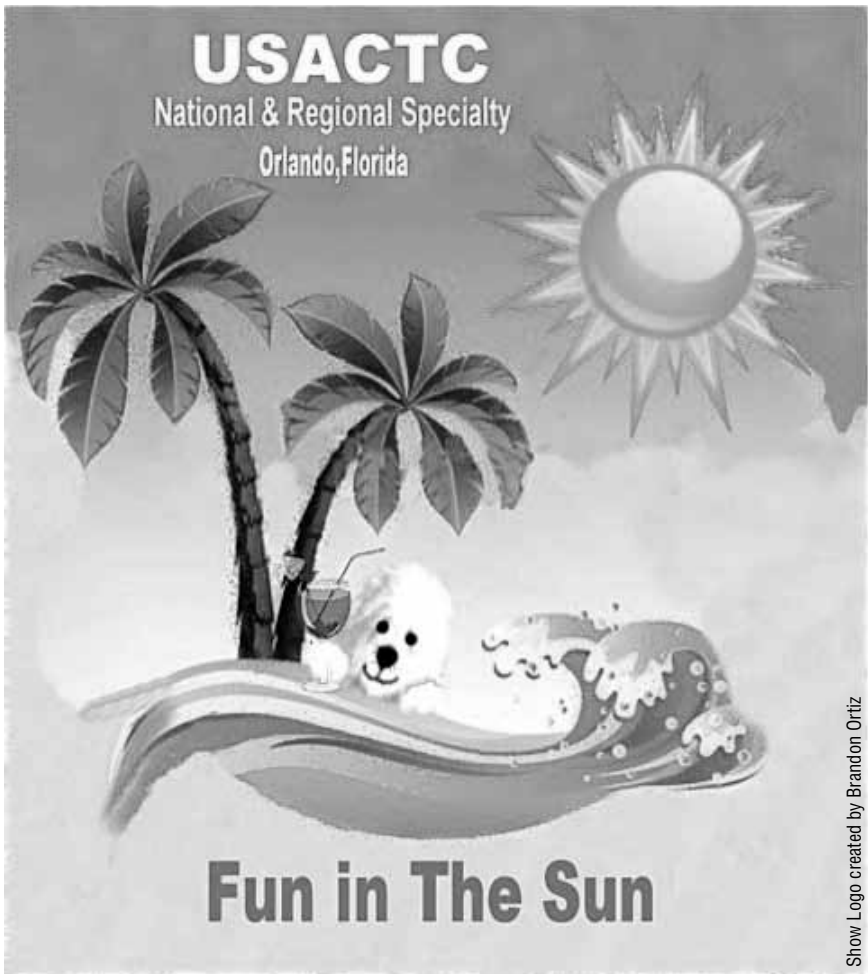

SWEEPSTAKES & VETERAN SWEEPSTAKES

To stimulate interest in the showing of promising young dogs and bitches and to honor our veteran dogs and bitches, Sweepstakes will be held in conjunction with our Specialty Shows both days. Sweepstakes will be judged prior to the Regular Classes. All dogs and bitches entered in Sweepstakes MUST ALSO be entered in a Regular Class at this Specialty, at the regular entry fee. The Puppy Sweepstakes is open to all dogs who are at least 6 mos. of age and under 18 mos. of age on the day of the show. Veteran Sweepstakes is open to all dogs who are at least 7 years old on the day of the show. Spayed and Neutered veterans may be entered.

ENTRY FEE: \$25.00 for each entry in Sweepstakes in addition to regular entry fee. Entries must be made at the same time and on the same entry form as the regular classes, indicating Sweepstakes in the space for "Additional Classes" your entry in Sweepstakes.

Non-Regular Classes Involving Single Dog Entries

Veteran Dog Veteran Bitch

A class for Dogs and a class for Bitches, 7 years of age and older. Dogs/bitches entered in Veterans need not be intact. Winners of the Veteran Classes, if otherwise undefeated, are eligible to compete in Best of Breed competition.

BEST OF BREED

Non-Regular Classes Involving Multiple Dog Entries

Stud Dog • Brood Bitch • Brace

The Puppy Class shall be for dogs that are six months of age and over, but under twelve months, that are not champions.

The Twelve-to-Eighteen Month Class shall be for dogs that are twelve months of age and over, but under eighteen months, that are not champions.

The Novice Class shall be for dogs six months of age and over, which have not, prior to the date of closing of entries, won three first prizes in the Novice Class, a first prize in Amateur-Owner Handler, Bred-by-Exhibitor, American-bred, or Open Classes, nor one or more points toward their championships.

The Amateur-Owner-Handler class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

The Bred-by-Exhibitor Class shall be for dogs that are: • Six months of age or older as of the first day of the show; • Not Champions on the date of closing of entries for the show; • Individually registered with AKC FSS • Owned or co-owned by any of the breeders of record as of the date of the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which a dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

The American-bred Class shall be for all dogs (except champions) six months of age and over, whelped in the United States of America, by reason of a mating which took place in the United States of America.

The Open Class shall be for any dog six months of age or older.

The Winners Class shall be divided by sex and each division shall be open only to undefeated dogs of the same sex which have won first prizes in either the Puppy, Twelve-to-Eighteen Month, Novice, Amateur Owner-Handler, Bred-by- Exhibitor, American Bred or Open Classes. There shall be no entry fee for competition in the Winners Class. USACTC Championship points shall be awarded to Winners Dog, Winners Bitch or Best of Winners. After the Winners prize has

been awarded in one of the sex divisions, the second prize winning dog, if undefeated except by the dog awarded Winners, shall compete with the other eligible dogs for Reserve Winners. No eligible dog may be withheld from competition.

Best of Breed The following categories of dogs may be entered in this competition: Dogs/Bitches that are Champions of Record in any registry. Because the USACTC has recently been approved by AKC as the Parent Club, the USACTC wishes to be inclusive of all of those Coton de Tulears which are registered and have completed the title of championship within any registry. A copy of the championship certificate or registration certificate showing the title of champion shall be required to be provided to the ring steward when the armband is picked up at the show. The steward will not be required to verify the championship, however, the copies shall be placed into an envelope, should they be needed for further verification by the USACTC. USACTC Championship points and/or ranking points will be awarded to Best of Breed and Best of Opposite Sex to Best of Breed. In addition, the Winners Dog and Winners Bitch together with the winner of Veteran Dog and Veteran Bitch classes at the show only shall compete for Best of Breed. A dog that has been defeated in any regular class or non-regular class at the show is ineligible to compete for Best of Breed.

Best of Winners If the Winners Dog or Winners Bitch is awarded Best of Breed, it shall be automatically awarded Best of Winners; otherwise, the Winners Dog and Winners Bitch shall be judged together for Best of Winners following the judging of Best of Breed. The dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.

Best of Opposite Sex to Best of Breed After Best of Breed and Best of Winners have been awarded, the judge shall select Best of Opposite Sex to Best of Breed. Eligible for this award are: Dogs of opposite sex to Best of Breed that have been entered for Best of Breed competition; the dog awarded Winners of the opposite sex to the Best of Breed; the winner of the Veteran Class of the opposite sex to Best of Breed at the show only .A dog that has been defeated by a dog of its own sex in any regular or non-regular class at the show is ineligible to compete for Best of Opposite Sex to Best of Breed.

Award of Merit After Best of Opposite Sex to Best of Breed has been awarded, the judge may choose to give Awards of Merit to those dogs exhibiting meritorious qualities which the judge wants to reward. There shall be up to one Award of Merit per 2 dogs/bitches entered in Best of Breed.

Stud dog/Brood Bitch Stud dog/Brood Bitch must be entered in the Stud dog/Brood Bitch Class and must be shown in the ring with their two of their get. The Stud Dog or Brood Bitch need not be intact. The owner of the Stud dog/Brood Bitch need not necessarily be owner of the get. While the merits of the Stud dog/Brood Bitch are not to be considered in the placement of the entry, the Stud dog/Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the standard of the breed. Get must be entered in a regular class or Best of Breed Competition.

Brace – A brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner.

The National Show, Regional Show, National Sweepstakes, Regional Sweepstakes and Special Attractions will follow the current AKC Rules Applying To Dog Shows, with exceptions being made regarding USACTC as FSS breed. For more information, please see <http://www.akc.org/pdfs/rulebooks/RREGS3.pdf>

SPECIAL ATTRACTION PUPPY COMPETITION

Bring your Beginner Puppies (4-6 months of age) to the 4-6 Month Special Attraction! Entries will be taken at the show. There is no pre-entry.

Classes are offered for Coton de Tulear puppy dogs 4-6 month and puppy bitches 4-6 months. The winners of each 4-6 month class will compete for Best Beginner Puppy in Competition. The winners of these classes are not eligible to compete in the regular show, nor sweepstakes.

A registration number or litter number is required for entries. Dogs must be four months of age or older but under 6 months. Dogs are required to be vaccinated in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized. AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise. Note: Exhibitors should plan on showing the bite of their puppy for the judges as well as regular table exam and movement. Consideration of age will be made by the judge in application of breed standard regarding qualities such as color, height, weight and/or dentition.
