BARK THE ALERT!

Proposed Federal Regulations Threaten the Future of Small Breeders and Fanciers!


The U.S. Department of Agriculture (USDA) has proposed administrative changes to the Animal Welfare Act that would subject anyone who maintains more than 4 "breeding females" and sells one pet sight unseen to strict federal licensing, regulation and inspections as a USDA commercial breeder. The term "breeding female" is not defined so no one knows who would be impacted.

This includes any transfer where a buyer doesn't pick up the dog directly from the seller —even among co-owners, long-time associates or a "puppy back" as back as part of a breeding agreement.

The proposal includes multiple species – you could own only one intact female dog (along with other species) and still be subject to USDA commercial breeder regulations if you sell a single puppy sight unseen.

USDA commercial breeder regulations were not intended or designed for small hobby breeders. It is unreasonable and virtually impossible for responsible hobbyists who keep dogs in their homes to comply with regulations designed for large, commercial operations.

This is a proposed administrative change to existing law, not new legislation, so we need YOUR involvement NOW.

USE OF RAMPS

At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: *Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, **Basset Hounds, *Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, **Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. *Boykin Spaniels and Whippets may be examined on the ground, on a table or on a ramp. **Basset Hounds and Bulldogs are expected to be judged on the ramp during breed judging. For the judging of Juniors, the ramp may be used at the discretion of the judge for the ramp breeds. This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

- These are self-cleaning shows. Equipment will be placed around the show grounds and outside show rings. If your dog soils the grounds, it is your responsibility to clean it up and place contents n the trash cans. By signing the entry forms for these shows, you are agreeing that clean-up is your responsibility. If you see an area that has not been cleaned, please notify our announcer. Also, please return our equipment for the next person to use. Because of the carelessness of some exhibitors, show sites are becoming more difficult to obtain. Arizona White Mountain Kennel Club asks your cooperation in cleaning up after yourself and your dogs. Exhibitors are responsible for cleaning up their own grooming area.
- No set-ups, exercise pens, grooming tables, etc. permitted in the aisles, and no grooming within 20
