REFUNDS: Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. Bitches in season are not permitted at the trial. Entry fees, less a recording fee of \$10.00/day of entries for bitches who come into season before these trials take place will be refunded provided the trial secretary receives notices in writing by April 9, 2005, no later than ½ hour prior to judging. A written excuse on official Veterinarian's letterhead will be the only acceptable method. There is no refund for duplicate entries. We will make every effort to find all duplicate entries, but if the entry has been processed, no refund will be made.

HEIGHT DIVISIONS

Owners / Agents are responsible for entering the proper height divisions. All Height divisions will be offered in both the Standard classes and the Jumpers With Weaves classes.

Regular: Exhibitors may choose to enter their dog in a higher height division than required by AKC, but not in a height division lower than the AKC mandated height.

Preferred: The following jump heights specified for Preferred must be used in all Preferred Classes.

Dogs 10 inches and under at the withers	8 inches	4 inches
Dogs 14 inches and under at the withers	12 inches	8 inches
Dogs 18 inches and under at the withers	16 inches	12 inches
Dogs 22 inches and under at the withers	20 inches	16 inches
Dogs over 22 inches at the withers	24 inches	20 inches

Junior Handler Information

Junior Handler certification forms can be obtained from the Trial Secretary on the day of the show. The judge who certifies that the Junior handled the dog must sign the form. One copy of the form will be included with the judge's book which is sent to the AKC, and the other copy is to be retained by the Junior Handler.

Dogs Eligible to Enter

This Licensed trial is open to all dogs over the age of 12 months that are registered with the American Kennel Club or are registerable breeds that have obtained AKC ILP numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Refer to Chapter 12 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

OBSTACLES

Obstacles shall meet the specifications for obstacles in the current edition of the Regulations for Agility Trials and will be supplied by Nestle Purina Farms and Excellence In Motion Training Club.


