Non-regular Classes involving single dog entries:

Separate Classes in each classification for Dogs and Bitches.

Except for Veterans, all dogs and bitches in these classes must be intact: **Hunting Retriever Class:** Dogs/Bitches with an AKC Hunting Retriever Test title. **Field Trial Class:** Dogs/Bitches with a JAM or better in an AKC Licensed Field Trial.

Veteran Classes I: Dogs/Bitches EIGHT (8) years and under TEN (10) years.

Veteran Classes II: Dogs/Bitches TEN (10) years and older.

Winners of the above classes, if otherwise undefeated, are eligible to compete in Best of Breed competition. Following Best of Breed judging, there will be an award for Best Veteran.

Please note the minimum age requirement for the Veteran classes!

Non-regular Classes involving Multiple Dog Entries:

Stud Dog Class: For Stud Dogs and at least two (2), but not more than three (3), of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the Standard for the breed. Get must be entered in a Regular Class, Best of Breed Competition or some other non-Regular Class.

Brood Bitch Class: Same rules as for Stud Dog, except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class: Two Labrador Retrievers that are similar in appearance, performing in unison. Both dogs competing in brace competition must have at least one common owner. The Dogs comprising a Brace MUST be named at the time of entry. In making entries for "Brace Class Only" full particulars MUST be given for each dog on individual entry forms. An entry form for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be designated "Brace No. 1," Brace No. 2," etc. The entry fee for Brace Competition is \$30 per Brace.*

*In addition to the brace unit fee, each dog in the Brace requires a "first entry" fee unless it is entered in another class at the "first entry" fee.

NOTE: As the judge's decision in the Stud Dog, Brood Bitch, or Brace Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE JUNIOR CLASS - For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show. NOVICE SENIOR CLASS - For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN INTERMEDIATE CLASS - For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN SENIOR CLASS - For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

MASTER CLASS - This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year. NOTE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, a \$15.00 fee applies.

PUPPY SWEEPSTAKES

To stimulate interest in the showing of promising Labrador Retrievers, the Labrador Retriever Club will hold annual Sweepstakes Classes at its National Specialty Show. Puppy Sweepstakes rules are as follows:

- 1. Labrador Retrievers 6 months and under 18 months are eligible.
- 2. Champions of Record in any country are ineligible.
- 3. Sweepstakes Classes will be judged prior to or after the Regular Puppy Classes as appropriate for the number of entries, but not concurrently.
- 4. Specific Sweepstakes Classes must be given on entry blanks in space marked "Additional Classes." State Sweepstakes Dog or Bitch, proper age and color (Black or Any Other Allowed Color/AOAC.)
- 5. Entry fee due with regular fee.
- 6. If any dog becomes ineligible after the close of entries, the dog must be withdrawn. Entry fee will not be refunded.
- 7. Dogs MUST also be entered in a Regular Class.
- 8. Entry fee is \$20.
