#### NOTICE TO EXHIBITORS – ALL EVENTS

If the Best of Breed is awarded to a dog/bitch coming from one of the Veterans Classes for that breed, the Best Veteran win is automatic. First through Fourth Place in each Group will be awarded a rosette, with the Group winner going on to the Best Veteran in Show. At the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: \*Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, \*\*Basset Hounds, \*Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, \*\*Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, Norwegian Buhund and Polish Lowland Sheepdogs. \*Boykin Spaniels and Whippets may be examined on the ground, on a table or on a ramp. \*\*Basset Hounds and Bulldogs are expected to be judged on the ramp during breed judging. For the judging of Juniors, the ramp may be used at the discretion of the judge for the ramp breeds. This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. There will be a selection of Best 4 & Under 6 Months Puppy in each Breed/Variety, each Best 4 & Under 6 Months Puppy in Breed/Variety winner will then complete in their respective group for First through Fourth Placements. The Miscellaneous Class Competition will be judged same as above followed by a Miscellaneous 4 & Under 6 Months Puppy Group Competition. The Foundation Stock Service Class Competition will be judged same as above followed by a FSS 4 & Under 6 Months Puppy Group Competition. 


