#### PLEASE COMPLY WITH THE FOLLOWING RULES & RESTRICTIONS FOR HOTEL GUESTS WITH DOGS

- 1. Dogs are to be crated when in guest rooms.
- 2. Plastic is required under all crates, to be provided by the host club.
- All rooms must be available for cleaning and ALL privacy signs must be removed no later than 11AM each day unless prior arrangements are made. NO EXCEPTIONS. Anyone refusing service will be charged an additional \$25 per day of refused service.
- 4. For the safety of resort staff, all rooms must have a sign on the outside of the door to indicate dogs are occupying the room. The Housekeeping Staff requires that you allow cleaning daily.
- 5. Dogs MUST be on a leash when walking in resort rooms, hallways or any public areas of the hotel.

# JUNIOR SHOWMANSHIP COMPETITION

- **NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.
- **OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.
- MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.
- NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

Owner of Brood Bitch need not necessarily be owner of Produce. Produce only to be judged, based on the merits of the Produce. Produce must be entered individually in one of the Regular Classes, Best of Variety Competition or some other Non-Regular Class. AKC Ch. 11, Sec. 8: A spayed female may be enetered as Brood Bitch in the Brood Bitch Class.

**Brace Class** (\$18 for Unit) – Two Dogs of the same variety and must have at least one common owner and presented by a maximum of two handlers.) – The dogs comprising Brace MUST be named at the time of entry. If a dog who is to be part of a brace is not entered in any of the Regular Classes or for Best of Variety Competition, it must be entered for "Brace Class Only."

As the Judges' decision in the Stud Dog, Brood Bitch and Brace Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Variety by virtue of having won these classes.

MAJORS provided that the number of dogs competing in the regular classes of the reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held. #### INGA FROM SEMINAR: POSITIVE GUN DOG TRAINING

Inga is a former game warden and founder of PGDM who is both a Certified Dog Behavior Consultant and Certified Professional Dog Trainer. She has worked with the MN Chapter of NAVHDA in the past and is familiar with versatile hunting dogs. She will present on positive reinforcement training as applied to gun dogs.

#### GUEST SPEAKER: L.B. Lon Hodge, MA, MFA, EdD/ABD, PhD & Gander

This year's topic: In Dogs We Trust: Love, laughter and loyalty. The relationship between a man and his dog.

Veteran Traveler Lon Hodge travels the country advocating for service dogs, PTSD awareness and suicide prevention. He is a disabled veteran and handler for Gander, Service Dog, his battle buddy of three years.

In December, Gander was awarded the AKC Award for Canine Excellence for 2014-2015. Gander is the Service Dog Foundation Ambassador and the face of this year's Dog is Good Patriotic Campaign which is raising money for Freedom Service Dogs who gifts 30 dogs a year to people with physical disabilities.

Lon is a writer and editor and a former Professor of Psychology and Literature. He chronicled his own experiences recently in In Dogs We Trust: an anthology of inspirational canine stories. His has been a National Endowment for the Arts Fellow in Literature/Writing/Poetry and in other past incarnations: Professional Archer, TKD/Hapkido International Master Instructor, Soldier of the Year and National Bowhunter and Outdoorsman of the Year. He did Enlisted and Commissioned service in the US Army in the Medical Corp and as an EOD Trained Ordnance Officer.

In the last two years Gander and Lon have visited over thirty states and given over 300 presentations to service clubs, associations, schools, and businesses. They hope to make it to all the lower 48 this year. He is working on a book entitled, Fetch: Gander's America, which will be out later this year.

Her practice is devoted entirely to prenatal diagnosis and genetics. She is nationally recognized for her work in fetal echocardiography and 3-4D ultrasound and speaks extensively on these topics. She is also an officer for the American Institute of Ultrasound in Medicine, and a consultant/speaker for GE Healthcare.
