NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. Note: As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won the class. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

STUD DOG CLASS – For Stud Dogs and their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their get. Stud Dog need not be entered in any other class. The owner of the stud dog need not necessarily be owner of the get. While the merits of the stud dog are not to be considered in the placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a regular class, Best of Breed Competition, or some other Non-Regular class.

BROOD BITCH CLASS – For Brood Bitches and their Produce. Brood Bitch must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. Brood Bitch need not be entered in any other class. The owner of the brood bitch need not necessarily be owner of the produce. While the merits of the brood bitch are not to be considered in the placement of the entry, the brood bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard of the breed. Produce must be entered in a regular class, Best of Breed Competition, or some other Non-Regular class.

BRACE CLASS – Two dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned or exhibited by professional handlers* meet the requirements for this competition.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any competition during the entire show. Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog.

All Specialties in this Cluster that are offering Obedience Classes will be judged together. Each dog will be judged and individual scores recorded in the respective breed's judge's book. For the group exercises in Obedience, all breeds will be judged in one group. Animals left in vehicles will be monitored by County Control Officers and Club Members. If animals are in distress due to heat or any other circumstance, the vehicle will be forcibly entered, the animal recovered and the owner cited.
